Contract Terms:

1. UMG agrees to provide Talent/Services for Client listed above on the specified date.
2. It is client's obligation to know if UMG will need to provide Liability Coverage as Talent/Vendor. Proof of Liability Coverage is available at an additional cost to the booking fee and is based on number of guest attending your event. UMG Talent/Equip does not operate in extreme rain storms, direct sunlight, extreme heat/cold temperatures, faulty floor settings and power inserts. It can cause equipment damage and harm to Vendor/Talent. Venues with flights of stairs/levels without elevators, is an additional \$100.00 for labor.
3. Client agrees to pay ULTD MUZIK GROUP the total amount of \$ _____, which includes the deposit mentioned on payment page. This total amount includes all fees (consultation, travel, tax not included.)
 - a. Final payment is due **2 weeks (14 days)** before your event. If payment is not received 14 days before your event date, an additional **\$25.00 late fee/service fee (per day)**, will be added to your remaining balance.
4. Musical requests must be supplied to UMG no less than **1 week (7 days)** prior to the event. An additional \$50.00 late labor fee will be applied and is due prior to Vendor Service/talent performance.

In the event of cancellation:

**A written cancellation (via email) must be provided more than 30 days prior to the event. If client wishes to cancel services after final payment is paid, Client shall receive 50% of final payment balance only. Said returns are refunded 2 weeks prior to your scheduled event date. All payment refunds over \$100.00 will need proof of ID if UMG has to refund to any other source other than the original payment source and will take up to 2 weeks after your event
